Announcement of Scholarship Progamme for Diaspora Children (SPDC) for the Academic Year 2024

The Ministry of External Affairs, Government of India has announced the Scholarship Programme for Diaspora Children (SPDC) scheme for the children of the Indian Diaspora for the academic year 2024-25. This scheme will be applicable for those children of PIOs /OCIs and NRIs for pursuing under graduate course in several disciplines in India.

- 2. SPDC scheme is applicable to eligible applicants from NRI/PIO/OCI community in all foreign countries and also those foreign students have taken admission in Indian institutions for first year undergraduate student (other than Medical courses) and those students who are pursuing UG medical courses in Indian Colleges. The SPDC Scheme has been extended up to 30th November, 2024.
- 3. Under the SPDC Programme total seat is 150, out of which 50 slots are reserved for Children of Indian Workers in ECR Counties. Further, out of 50 slots, one-third of slots (i.e 17 slots) shall be reserved for those Children of Indian workers in ECR Countries who have studied in India.
- 4. The selection of the applicants for scholarship will be on Merit-cum-Means basis.
- 5. The applicants for all categories must have passed grade 11th and 12th from abroad. However, the children of the Indian worker of ECR Countries who have studied in India, must have passed grade 11th and 12th or equivalent examination from a system of education recognized by the Association of India Universities (AIU).
- 6. The following institutions are covered under the SPDC Scheme.
 - (a) A Grade institutions accredited by National Assessment and Accreditation Council (NAAC) and recognized by UGC,
 - (b) National Institutes of Technology (NITs) Schools of Planning and Architecture and Indian Institutes of Information and Technology (IIITs) through DASA Scheme.
- 7. The admissible amount of scholarship would be 75% of the total Institutional Economic Cost (IEC) subject to a maximum of US\$ 4,000/- per annum which includes Tuition Fees, Hostel fess & other institutional charges except food charges.
- 8. The total income of the parent(s) of the NRIs/PIOs/OCIs category applicants not exceed an amount equivalent to US\$ 5,000/- and the total monthly income of the parent(s) of Indian worker in ECR category applicant should exceed an amount of equivalent of US\$ 3,000/-
- 9. The guidelines and application form, an undertaking and details of courses under the SPDC programme are attached herewith.
