Officials from Indian Embassy periodically visit the jail/detention centre in Lebanon to meet Indian detainees/prisoners and provide consular/social and legal support. The visits are made after obtaining due permission from the local authorities. Besides, members from NGOs/voluntary organizations such as CARITAS also visit jails for providing assistance to the inmates.

Since no Indian national is being held or arrested for capital punishment in Lebanon, no concrete action was initiated. However, Embassy of India, Beirut will continue to extend all necessary assistance to the detainees/prisoners as part of the outreach programme with the Indian expatriates.
